OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING THE SURVEYPOLICE MAY DAYS SWEEPSTAKES IS SPONSORED BY AFFILITY MEDIA INC. (THE "SPONSOR").

SWEEPSTAKES DETAILS: NO PURCHASE NECESSARY. The SurveyPolice May Days Sweepstakes (the "Sweepstakes") starts at 12:00:00 AM Pacific Time (PDT) on Friday, May 1, 2020 and ends at 11:59:59 PM PDT on Thursday, May 14, 2020 (the "Sweepstakes Period").

Sponsor's computer is the official time-keeping device for the Sweepstakes.

1. ELIGIBILITY:

SWEEPSTAKES IS INTENDED FOR RESIDENTS OF CANADA (EXCLUDING THE PROVINCE OF QUEBEC) AND THE 50 UNITED STATES, and the DISTRICT OF COLUMBIA who are at least EIGHTEEN (18) years of age or older at the time of entry. These SWEEPSTAKES shall be governed in accordance with the laws of the province of BRITISH COLUMBIA. Employees of Affility Media, Inc., and any of their respective related companies, parents, subsidiaries, affiliates, and agents and any agencies or other companies involved in the development or execution of the Sweepstakes or production or distribution of Sweepstakes materials, (collectively, the "Sweepstakes Parties"), and the immediate family members (parent, child, sibling, and spouse of each) of and/or persons living in the same household as such individuals (whether related or not) are not eligible to participate. Follow the on-screen instructions by writing a review for a survey panel, website or a GPT program (individually and collectively "Entries"). By clicking submit, and having the review marked as "Approved" by the Sponsor, the entrant will receive one (1) entry into the Sweepstakes. Reviews must abide by the **TERMS OF SERVICE** and our **PRIVACY POLICY** (<https://www.surveypolice.com/termsofservice>) and Feedback Guidelines

(<https://www.surveypolice.com/feedback-guidelines>) and must be marked as "Approved" by the Sponsor. Website Reviews that are submitted prior to the Daily Entry Period but are edited or revised or marked as "Approved" by the Sponsor during the Daily Entry Period will also be eligible. All Entries must be submitted by 11:59:59 p.m. PDT on May 14, 2020 as determined by Sponsor's computer to be eligible. All entrants are subject to all notices posted online including but not limited to the Sponsor's Privacy Policy (<https://www.surveypolice.com/privacypolicy>). Entries generated by script, macro or other automated means and entries by any means which subvert the entry process will be void. There is no limit to the number of entries permitted during the Daily Entry Period.

To protect your privacy, it is recommended participants send any mail-in entries in an envelope. Photocopied, illegible, or mechanically reproduced entries are not eligible. 3. LIMITATION OF ENTRY

There is no limit to the number of entries permitted during the Daily Entry Period, however entrants must only register as a member of SurveyPolice once, even if the entrant has more than one email address. In the event of a dispute, online entries will be deemed to have been submitted by the Authorized Account Holder of the email address submitted at the time of entry. "Authorized Account Holder" means the natural person who is assigned to an email address by an Internet access provider, online service provider, or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address.

11. WINNER DETERMINATION:

On the drawing dates set forth, a random drawing will be conducted using <https://www.random.org> by Sponsor from among all eligible entries received for the sweepstakes, whose decisions are final and binding in all matters relating to this Sweepstakes.
